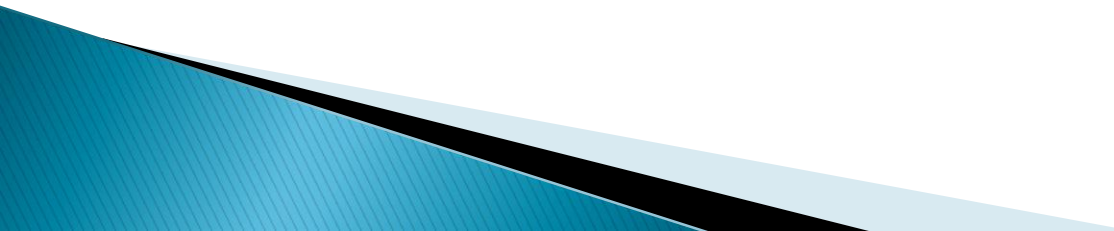


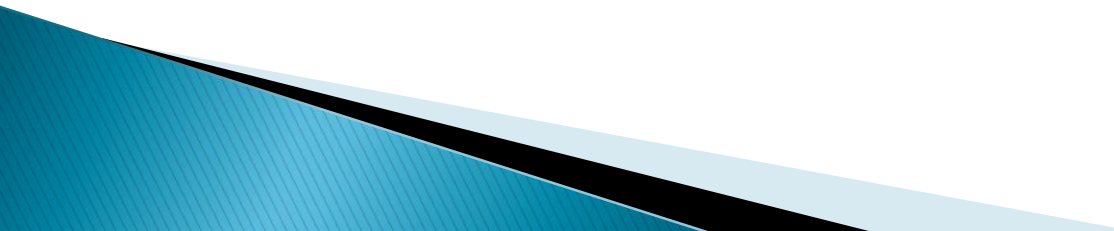
# Strange decisions from the Judge Carrard (Tribunal the Police)

- ▶ To reject the audition of most of the witnesses proposed by the denouncer (M.Goijman)
  - ▶ Among them, the IOC's Jacques Rogge and Paquerete Giscard, the former FIVB Vice-Presidents (Moreno and Andresen), the President of the FIVB Finance Commission, Jan Svenson, the Fivb Board Member Timo Santalainen, while accepting all the Acosta's witnesses..

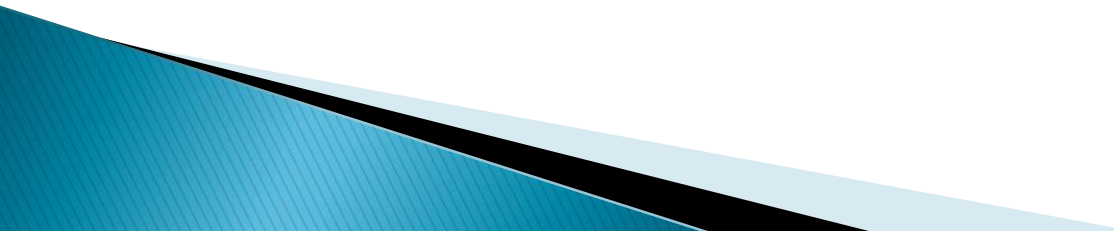
# Tribunal de Police Sentence

1. Existed an objective falsification of the Auditors Report
  2. Such falsification was made by Ruben Acosta and Franz Schmied.
  3. I have doubts about their intention to do it.
  4. Thus, in case of doubt, there is no crime, and I absolve them.
  5. They should pay the expenses of this Tribunal.

# Considerations about Judge's decision

- ▶ There had no importance, for the Judge, the fact of the more than 26 millions dollars taken by Acosta, and hidied with the trick of forgery of the FIVB's Statements. Is unbelievable that the Judge did not consider that, as an intentional forgery.
  - ▶ Goijman was not able to appeal this resolution because he is not a damaged party; only the denouncer.
  - ▶ The only one that may appeal was the FIVB, represented by the same lawyer. (what about ethics??)


# INSIDE the FIVB

- ▶ Acosta resigned, and made an agreement with his right hand, the 1<sup>st</sup> VicePresident Jizong Wei, to follow him and respect his line of conduction, and paying him the remaining commisions.
  - ▶ The VicePresidents, Cristobal Marte, Ary Graca, Andre Meyer, will continue and receive each one USD 500,000 every year for promotion without any explanation.
  - ▶ Wei will finish in 2012, together with all the Board, but the system of election was changed.

# WEI discoveries in April 2009

- ▶ Wei disclose to the Board meeting, that he was so astonished with the facts he found upon taking office, that he will not keep his promise to Acosta.
- ▶ He informed to the Board that the Acosta diverted funds were 33.000.000 USD.
- ▶ That the case of the house of Epalinges denounced by Goijman, was another illegal attitude from Acosta.
- ▶ That he recognizes, now that himself made many mistakes, following Acosta instructions, in spite of his own criteria.
- ▶ That the legal Commission followed not the rules, if not only Acosta wishes.
- ▶ That he helped in the condemnation of many innocents.
- ▶ That he regret all these actions of the past.

# FIVB's NEW Board decisions

- ▶ To change the elections system.
  - ▶ To change the Code of Conduct created by Acosta.
  - ▶ To change the FIVB's financial regulations, but with extreme care, because they did not want that any Judge may believe that Mario Goijman denounces were well grounded (sic)
  - ▶ To engage new management, and decide everything inside the Executive Committee.
  - ▶ Not to meet, in any way, with Goijman???

# FAV Claim for the funds retained since 2002

- ▶ The Argentina Federation claimed many times the sums retained by the FIVB, but rejected during Acosta regimen.
- ▶ The FIVB decided not to accept the devolution of the money.
- ▶ Rejected the reclaim by the Lausanne's Office of Pursuits.
- ▶ Rejected a joint meeting to discuss the issue.
- ▶ Rejected the proposal by FAV Lawyer of asking the mediation of the CAS (Court Arbitral from the IOC), or even the arbitration of the IOC

# Some explanations to the attached accounts 1

- ▶ A.– The amount received from TBS for the Mens World Championship 2002, for Japan, was fixed orally by Ruben Acosta in USD 600,000. He never show the contract neither accepted any audit review.
- ▶ B.– The amount given by Mikasa was fixed by Acosta in USD 50,000. But after the criminal lawsuit against Acosta, The Mikasa–FIVB contract was found by the Police, and attached to the suit.
- ▶ It was for 9'000,000 USD, and fixed that 10% was allocated to each World Championship in 2002.
- ▶ C. The FIVB signed a contract with the firm TURICENTRO for all the transportation for officials and teams, for a total amount of USD 545,000
- ▶ D/ F.– The regulation in the article 3.6.2, fixes an contribution for Lodging and Meals of no more than 20% of the Net Profit, and with a guarantee of a minimum of 50% of the real expenditures. The contracts signed between Hotels and FIVB was for USD 601.491; but ACOSTA fixed unilaterally USD 300.000, and that was paid by FIVB.

# Some explanations to the attached accounts 2

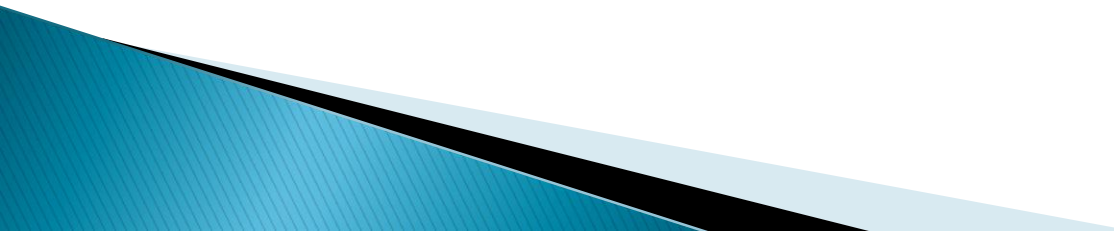
- ▶ E.– The balance to the FIVB is revised in the attached detail. We must clarify, that non advertising or promotion was spent by FIVB for the World Championship.
- ▶ G.– In 2008, FIVB gave to the Pursuit office such amount to be paid to three former FAV employees, through the office of the lawyer Mr. Petremand.
- ▶ H.– The commission of 10% was recognized by the FIVB for the sponsors: SANCOR– VISA–ORIGENES– Quilmes– and Quini 6. in the proposal prepared by the FIVB on November 7th 2002.
- ▶ I.– FIVB decided to appoint 17 more officials than the ones that were fixed in the Contract, and accepted to pay to each of them USD 1,100.

# HELP US!!!!


- ▶ We ask the intervention of the independent Press, through **PLAY THE GAME.**
