C. ATHLETE ELIGIBILITY

Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of IWF, may participate in the Olympic Games Paris 2024.

Age requirements

To be eligible to participate in the Olympic Games Paris 2024, athletes must be born on or before 31 December 2009.

Additional IF eligibility criteria

Athletes must also comply with the following criteria:

- Be fully compliant with the IWF Anti-Doping policy (https://iwf.sport/downloads/?did=2032)
- Are obliged to provide whereabouts information in ADAMS for the entire period 01 July 2022 to the opening of the Olympic Games Paris 2024. Shall be required to provide whereabouts for the whole of each year with that period, without pause.
- Participate in the 2023 IWF World Championships.
- Participate in at least one other of the competitions specified in section D of this document.

	 The OQR will be available on the IWF website at <link to be added>> Only performances achieved in the events to be contested at Olympic Games Paris 2024 will be listed in the OQR. At maximum, one (1) athlete per NOC shall be ranked on the OQR in each event. In the circumstance that two, or more, athletes record the same Total in the same bodyweight category they shall be ranked in order of which achieved the result first, using equivalent Greenwich Mean Times (GMT) to decide such if necessary.
	Following the end of the qualification period the highest OQR ranked nine (9) athletes in each event to be contested at Olympic Games Paris 2024 will be allotted a quota place.
	• If one of those is a person allotted a quota place because of their winning the 2024 IWF World Cup, then the next ranked athlete will be assigned the quota place.
	 If an athlete is ranked in the top nine (9) in more than one event in the OQR, then that athlete's NOC in consultation with the National Weightlifting Federation (NWF), as recognised by the IWF, must declare to the IWF by <<date be="" determined="" to="">> in which event that athlete will compete in Olympic Games Paris 2024, and the athlete will then be removed from the OQR in other bodyweight categories. Any declined ranking position and quota place will then automatically move to the next ranked athlete.</date>
	 Should a NOC record more than three (3) athletes per gender in the OQR for then the relevant NOC in consultation with the NWF must declare to the IWF by <<date be="" determined="" to="">> which of these athletes shall be allotted the quota places. Any athletes not so declared will then be removed from the OQR. Any declined ranking positions and quota places will then automatically move to the next ranked athlete.</date>
	The qualification period for the OQR shall begin on 01 July 2022 and conclude on 28 May 2024.

Fede	chieve the widest possible representation across the IWF recognised Continental rations (Africa, Asia, Europe, Oceania, Pan America) these allocations shall be rmined by the IWF using the following criteria:
	 A NOC may at maximum receive two (2) quota places, one (1) man and one (1) woman. Continental Federations with the lowest overall quota places by percentage for that gender by the previous sections in part D of this document should be preferenced.
	Such quota places may only be allotted to a NOC that has received no quota place in that gender in any weight category via the previous processes described in part D of this document.
	• Within the limitations of the previous dot points in this section, the highest ranked athlete in the OQR in all events should be allotted a quota place.
	If two, or more, athletes in the qualifying events in all weight categories are ranked equally in the OQR the athlete from the Continental Federation with the lowest percentage of already allotted quota places should be allotted a quota place.

HOST COUNTRY PLACES

The Host Country can qualify places through the OQR and the 2024 IWF World Cup.

If the Host Country does not qualify the maximum quota through the OQR and the 2024 IWF World Cup the Host Country is guaranteed four (4) quota places in Total, two (2) for men and two (2) for women.

If the Host Country qualifies quota places through the OQR and the 2024 IWF World Cup these remain, and the Host Country may add additional athletes of their choice to achieve the maximum specified in this section.

These athletes must also comply with the following criteria:

• At maximum one (1) per event.

Should the Host Country not use its full allotment of quota places unused places will be reallocated as per the process described below in the section F.

UNIVERSALITY PLACES (TEXT TO BE PROVIDED BY THE IOC)

Six (6), 3 Men and 3 Women, Universality Places are made available to eligible NOCs at the Olympic Games Olympic Games Paris 2024.

On <<date to be specified>>, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality Places. The deadline for NOCs to submit their requests is <<date to be specified>>. The Tripartite Commission will confirm, in writing, the allocation of Universality Places to the relevant NOCs after the end of the qualification period for the sport concerned.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

CONFIRMATION OF QUOTA PLACES

The IWF will publish the results of the quota allocation within <<number to be specified>> days after the end of the qualification period on its website <k to website>>.

The IWF will confirm in writing to the NOCs within <<number to be specified>> days after the last day of the qualifying period the quota places they have obtained. The NOCs will then have <<number to be specified>> weeks to confirm to the IWF if they wish to use these quota places, as detailed in section G. Qualification Timeline.

CONFIRMATION OF HOST COUNTRY PLACES

The Host Country must confirm in writing to the IWF by <<date to be specified>> the use of its Host Country Places.

F. REALLOCATION OF UNUSED QUOTA PLACES

REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline <<date to be specified>>, or is declined by the NOC, the quota place will be reallocated to the next highest-ranked athlete, not yet qualified, on the OQR, respecting the maximum quota per gender and per NOC.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused Host Country Place(s) will be reallocated to the next highest-ranked eligible athlete in the OQR, respecting the maximum quota per gender and per NOC.

REALLOCATION OF UNUSED UNIVERSALITY PLACES (TBD)

Any unused Universality Place(s) will be reallocated to the next highest-ranked eligible athlete of the same gender in the OQR who has not yet qualified for the Olympic Games and respecting the maximum quota per gender and per NOC. The process will be repeated until the quota has been filled for each gender.
