LOTTERIES ARE AN ESSENTIAL SOURCE OF FUNDING OF SPORTS

2 Billion €

Total money for sports funded by EL Members per year
(100 times more than the World Anti Doping Agency)

Lotteries' funding to sports represents 20% of national
sport public budgets in Europe

70% of this amount has been allocated to grassroots

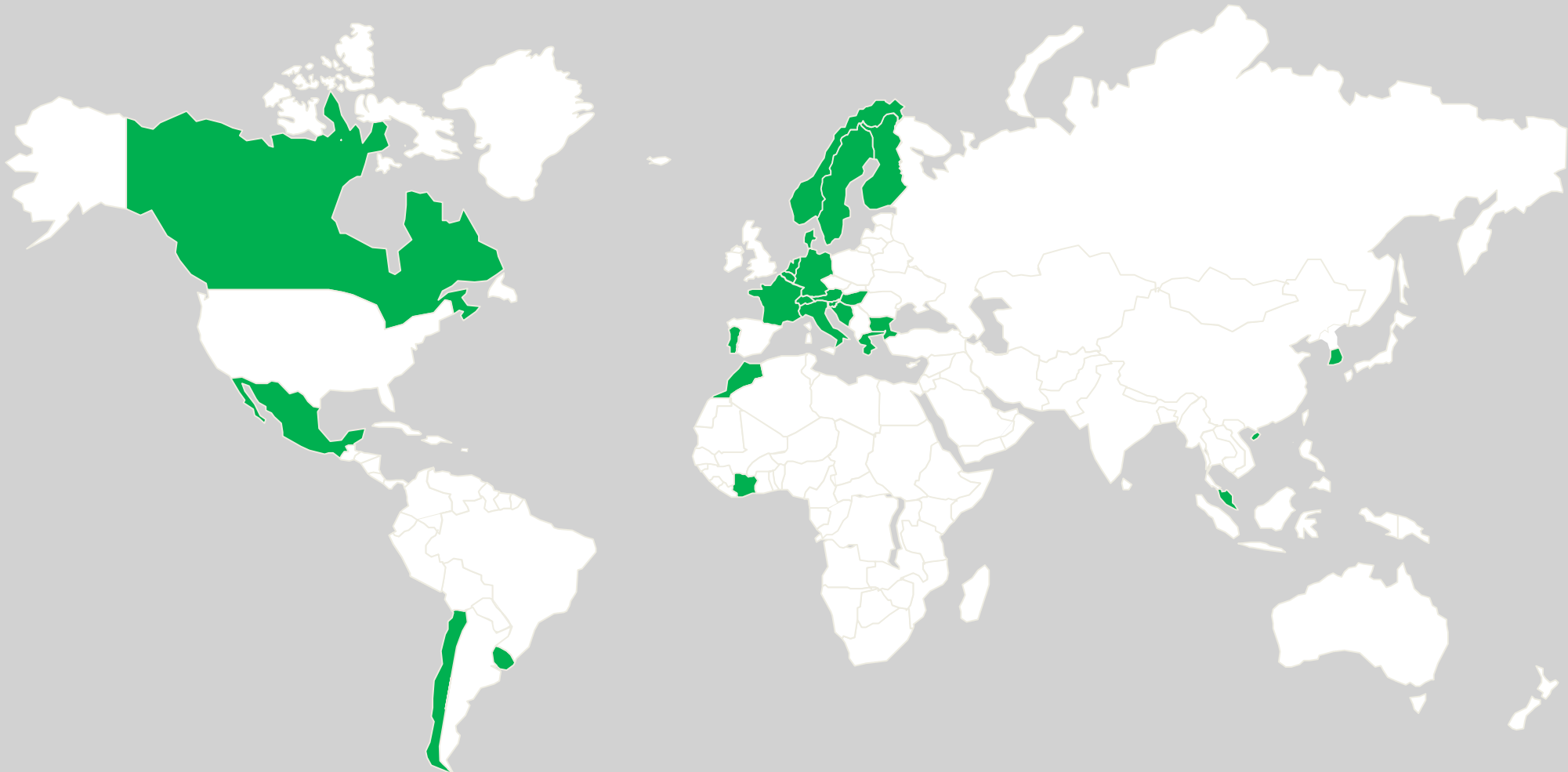

Consultation with GLMS Members through the GLMS online platform

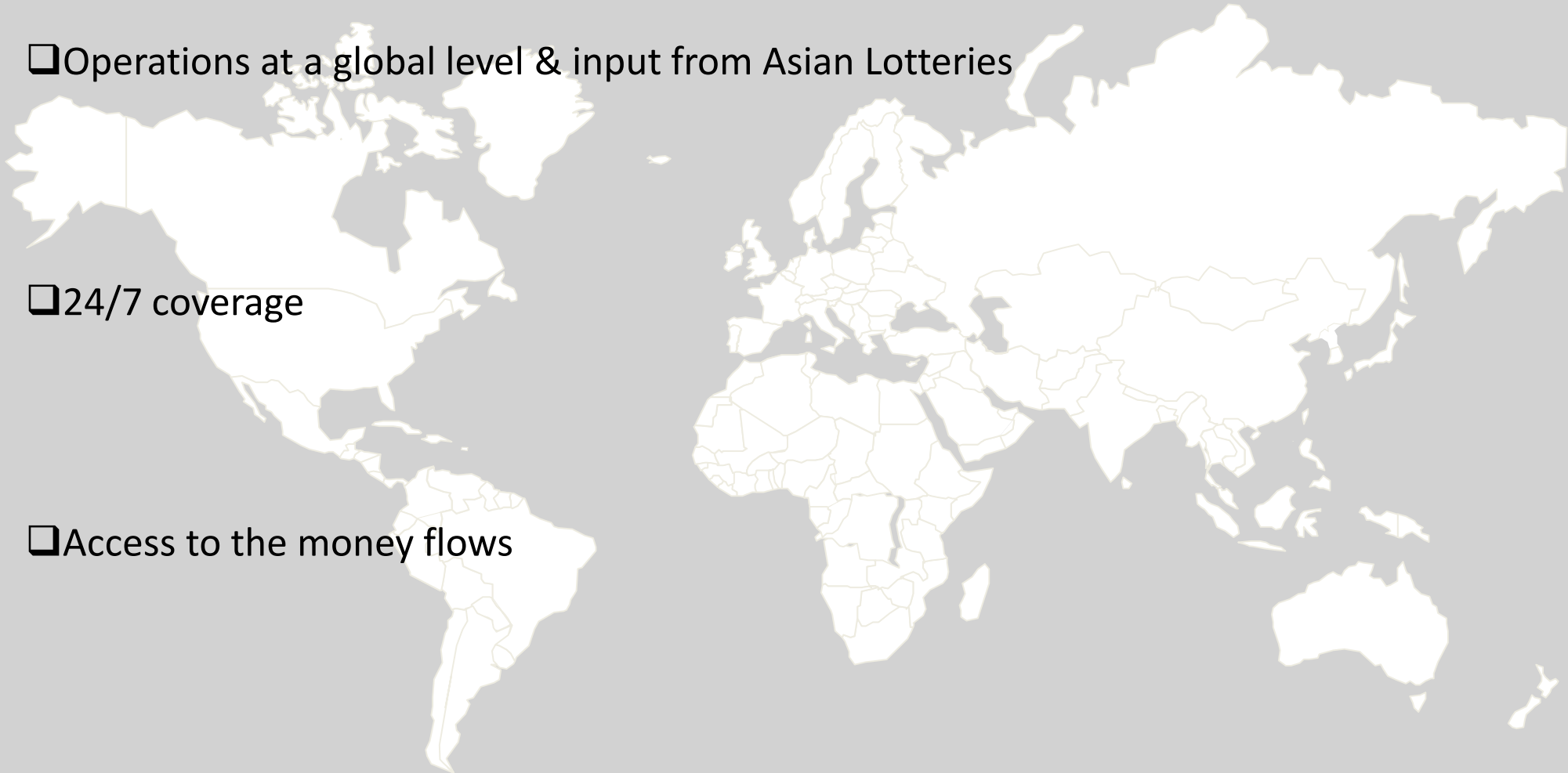
If abnormal betting patterns and/or odds changes cannot be justified on objective grounds, GLMS reports the match to the relevant sports organisations

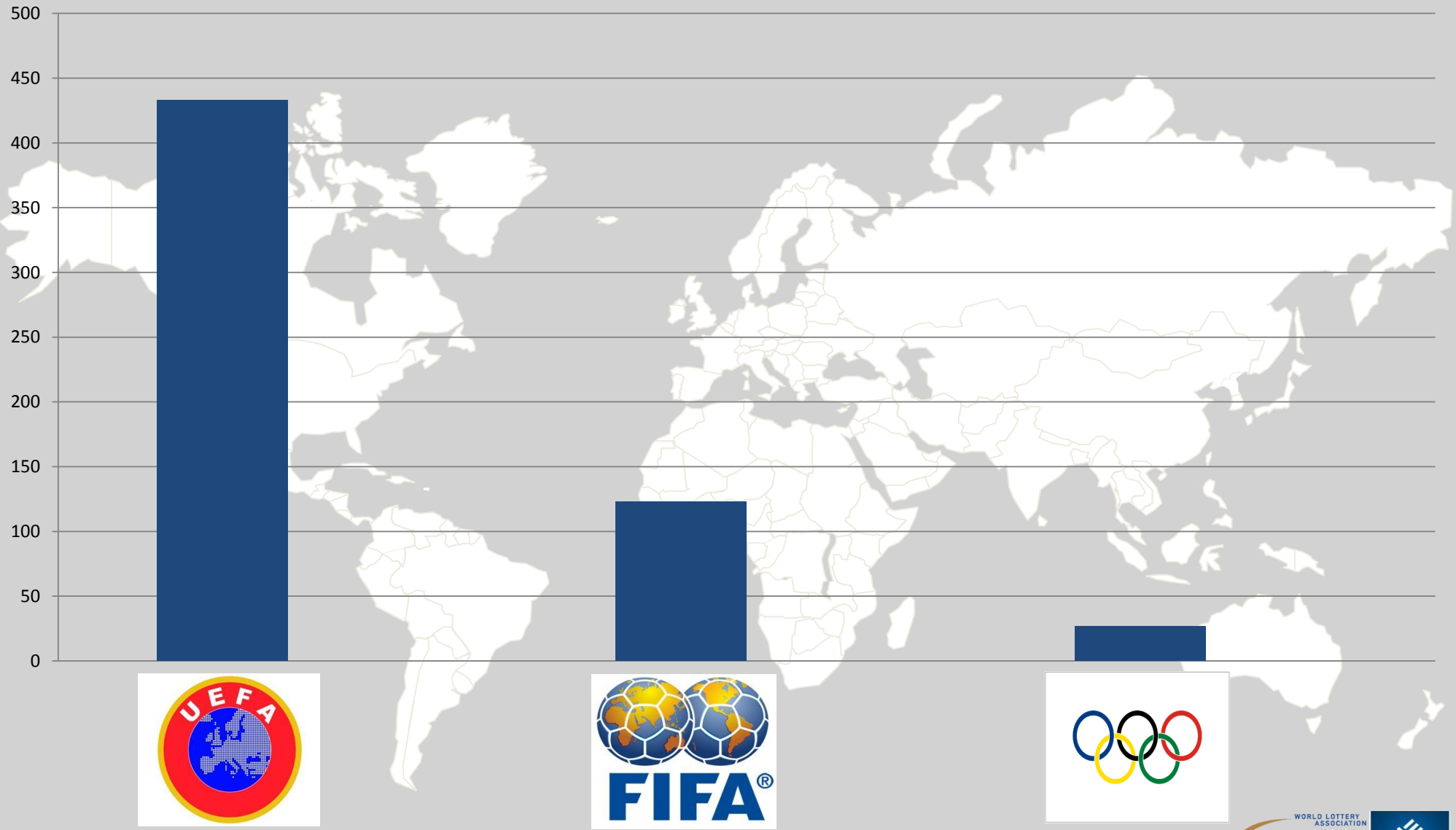
Operations at a global level & input from Asian Lotteries
